Since we were unable to connect by phone this week, I am writing to update you on what I found out regarding the need to continue our registered agent in Delaware.

I was told that it is necessary to have an agent here in Virginia, where we are doing business, and in Delaware where we were incorporated. The agent that represents us there is CT Coporation. They do not maintain any "minutes book" or other files. All they do is charge us an annual fee and process the annual fee we pay to the state of Delaware.

We were incorporated in October, so that is our "anniversary" date. I assume that means that we need to pay you your annual fee at this time. (Please invoice us accordingly.) In August I sent you copies of some of our basic paperwork. If you need any additional information, please let me know.

(I will be away from the office the week of Thanksgiving, but available again as of November 30.)
